The "Hoosier Rewards" contingency program is available to riders in every class that has **A MINIMUM OF SIX RIDERS** competing in the class. Contingency awards are available in the following classes; Pro ( Riders must be 18 or older on date on event to compete), Pro-Am (Riders must be 16 or older on date of event to compete), Pro Sport (Pro-Am/A), Open B, Open C, 450 B, 450 C, 450 B/C Limited, Production A, Production B, Production C, College (16-24), Junior 25+, Veteran 30+ B/C, Vet 35+, Senior 40+ B/C, WMX, Women (30+), Youth All-Star (13-15), Schoolboy Sr. (14-17), Schoolboy Jr. (13-15), Super Mini (12-15), Schoolgirl (13-17), Girls (8-12), 125 (8-15), 90 Open Sr. (12-15), 90 Open Jr. (8-11), 90 Automatic Jr. (8-12), 90 Shifter (12-15), 90 Shifter (8-11), 70 Open (6-8), 50 CVT (6-8), 50 Semi Stock (4-6) as listed on <a href="https://www.atvmotocross.com">www.atvmotocross.com</a>.

## PROGRAM REQUIREMENTS: WE NORMALLY SHIP WITHIN 10 DAYS!

- 1. Riders must use Hoosier ATV DIRT tires on all four corners.
- 2. Awards will be given to riders as shown in the table above (top right) while meeting the minimum number of riders in class.
- 3. A minimum of two (2) Hoosier decals must be displayed on the ATV.
- 4. Rider must have a ATV MX National Championship Official sign this form verifying requirements #1-#3 have been met.
- 5. Total completion of heats and mains required to receive contingency.
